### PENDING APPROVALS:

1. **Nockamixon Crossing Shopping Center** – Plan dated 6/7/05 for shopping center at intersection of Route 611/412. Refer engineering review dated 7/27/05; BCPC review dated 8/12/05; BCCD review not received. Extension requires action by 6/20/10.
2. **Hanson Aggregates BMC** – Proposed rezoning of TMP #41-11-100 to quarry. Refer engineering review dated 8/29/06; Clemons Associates review dated 6/27/06; BCPC review dated 2/7/07. Zoning challenge filed by applicant; ZHB decision appealed by Township.
3. **Wehrung Phase II Land Development** – Plan dated 7/13/04 for kitchen design center located along Route 611. Refer engineering review dated 9/1/05; BCPC review dated 8/19/04; BCCD review not received. Extension requires action by 6/30/10.
4. **Gross-Byers Road Subdivision** – Plan dated 7/17/07 for 2 Lot subdivision and lot line adjustment along Byers Road. Refer engineering review dated 7/30/07; BCPC and BCCD reviews not received. EAC review dated 8/29/07. Revised plan not received; Zoning Hearing Board appeal withdrawn. Extension requires action by 6/30/10.
5. **DiPalantino Land Development** – Preliminary plan dated 8/22/07 latest revision date 1/26/09 for Truck Terminal located along Route 611. Refer engineering reviews dated 1/31/08, 3/29/08, 6/26/08, 8/26/08, & 4/27/09; EAC review dated 2/20/08, 5/31/08, & 3/10/09; BCPC review dated 2/6/08; BCCD review not received. PC recommended conditional preliminary approval on 9/2/08 and 5/5/09. Extension requires action by 6/30/10.
- \* 6. **Hoffman Subdivision** – Preliminary plan dated 2/12/08 for 5 lot subdivision located along Marienstein Road. Refer engineering review dated 5/2/08; BCPC review dated 3/18/08; BCCD review not received; EAC review dated 4/7/08. Revised plan not received. Extension requires action by 5/30/10.
7. **Morton Subdivision** – Preliminary plan dated 2/2/07, latest revision date 11/13/09 for 3 lot subdivision located along Lonely Cottage Road; review forthcoming. Refer engineering review dated 5/28/08, 10/2/08, 4/28/09, & 12/22/09; BCPC review dated 5/13/08; BCCD review not received; EAC review dated 6/17/08. Extension requires action by 6/30/10.
8. **Gouck Minor Subdivision** – Final plan dated 12/2/08, latest revision date 3/8/10 for 2 lot subdivision located along Haycock Run Road. Refer engineering review dated 3/30/10; BCPC review dated 3/22/10; and BCCD review dated 3/24/10. PC recommended conditional approval at their 4/6/10 meeting. Awaiting submission to Supervisors. Action required by 7/5/10.
